## Terms of Service

Payment Terms. Due to the difficulty with debt collection, all payments for workshops, classes, events, Reiki sessions, or reading requests must be tendered in advance via Venmo, CashApp, Zelle, or cash. Please direct your payment preference type to Hannah at the time of your service request. Please note that all payment transfers are done through the third party platform(s) Venmo, CashApp, and Zelle, so please be familiar with the privacy policy and terms of use for these third party platforms. Virga is not liable for any mishandling by these third party platforms. In the event of third party mishandling, your claim will be with Venmo, CashApp, or Zelle directly. Virga does not accept checks, bank checks, wire transfers, or money orders. If your credit card is declined or payment is not properly transferred due to deficiencies on your end, then Virga will be entitled to the balance owed plus a 10% interest as additional charge for the deficiency.

Cancellation Policy. For in-person events, workshops, classes, readings, Reiki sessions, parties or live Zoom or Google Meet readings by appointment, to cancel you must send the cancellation notice to virgatarot@gmail.com at least 24 (twenty-four) hours in advance of the appointment, workshop, class, party, or event. Otherwise you will be bound to pay the session price even if you do not attend your session. When you purchase and schedule your in-person Reiki session, tarot reading, party, or live Zoom or Google Meet session, a fee will automatically be deducted from your potential refund amount in order to hold your spot. Due to the nature of our business here at Virga, cancelations are an enormous burden on us and greatly impact our ability to serve our clients. Thus, if you book a session, reading, or party, then we rely on your representation that you will fulfill your end of the arrangement and we will fulfill ours.
